## I. PRODUCT DESCRIPTION

The Sandman Clock is a 4-port USB charging station with an integrated alarm clock.

## III. INSTALLATION

The Sandman Clock features a power plug with a unique peg shroud.


Begin by pulling the shroud back away from the power connector.


Next plug the power connector into the power socket on the rear of the Sandman.


And lastly, move the shroud forward on the cable so that it pushes into the shroud groove channel and is inserted into the Sandman. Sit the Sandman on it's bottom feet, and this peg will now act as a kickstand.

## IV. USB WIRING

The Sandman is versatile in that it allows for several configurations of wiring your USB cables to the front of the clock, depending on space and preference.

- Route to the front via the under-body cut-out
- Route under and through the side cut-out
- Route around the back and side

## V. HOW TO USE IT

The Sandman has a simple interface with only 4 buttons.

## SET TIME:

To set the time, simply tap or hold the $\forall$ or $\square$ buttons to get to the correct time. Note that the PM indicator dot on the bottom right of the screen will show in 12 hour time mode.

## CHANGE BETWEEN 12/24 HOUR TIME:

To change the display between 12 hour and 24 hour time mode, simply press the $\square$ and $\square$ buttons at the same time once. The clock will display: "12:hr" or " $24: h r$ " to confirm.

## SET ALARM:

To set the alarm, simply hold the Anvom button until the digits blink. Then press the $\pm$ or $\square$ button to adjust the alarm time. Once done, press the and button again and the alarm will be set.

Note that the Alarm indicator dot is at the top left of the screen. When the dot is lit, the alarm is on

## SNOOZE ALARM:

To snooze, simply press the
TOP BUTTON. This will delay the alarm buzzer for 9 mins.

## TURN ALARM ON OR OFF:

To turn the alarm on or off, press the and amor button. The indicator light at the top left of the display will light when the alarm is on and it will not show when the alarm is off.

## ADJUST BRIGHTNESS:

The Sandman will automatically adjust its brightness via a light sensor in the front. In a dark room, it will go into Night Mode and the digits will dim. In a well lit room, it will go into Day Mode and the digits will brighten up to max to be visible across a room.

Note that some lighting may not be dark enough or bright enough to trigger this.
If you'd like to adjust the brightness of the clock manually in either Night Mode or Day Mode, be sure to be in a room with the appropriate darkness or light, then simply hold the Top BUTTON and press $\square$ or $\square$ to adjust the brightness.
If the display is very dim or off, simply press the TOP BUTTON and the display will temporarily brighten up.

## ADVANCED FEAUTRES:

## Daily alarm:

The Sandman has the ability to have the alarm go off at the same time every day.
To turn this on, enter alarm mode by holding down the andor button until the clock says "AL:Ar". Then press the top Button until the clock says "da:ly", the alarm dot indicator will flash quickly. Now when the alarm is turned off it automatically turns back on and will sound again in 24 hours. To go back to the original mode, hold down the TOP BUTTON while in alarm mode until the Sandman displays "ON:cE". Changing the alarm sound:

If the Sandman alarm is not loud enough for you, hold down the butuor button until it start to beep and displays "Lo". At this point you can press the $\square$ or $\square$ buttons to switch between "Lo" and "Hi" alarm tones.

## AUTO DIMMING ADJUSTMENT:

The Sandman has a brightness sensor located on the bottom left corner of the screen that measures the brightness of its environment. Sometimes the Sandman has a hard time with the lighting in certain rooms, this will help you adjust it.

Before starting this process make sure you have dimmed the display to the desired brightness in the current lighting conditions. See "ADJUST BRIGHTNESS" previously mentioned in the manual.

Enter brightness mode by holding the and Top button at the same time until the screen says "bri". At the point the Sandman will show a number and either "da" for day or "ni" night. The number will show how bright the Sandman thinks it is in the room on a scale from O-99.

At this point the Sandman is ready to remember the lighting conditions for either day or night.
Press the $\square$ button if it's currently day.
Press the - button if it's currently night.
AT THIS POINT STEP AWAY FROM THE SANDMAN.
The Sandman will count down from 3 and then it will automatically set your Sandman auto-dim threshold. If your Sandman does not auto-dim correctly try programming the other mode (day or night).

## BATTERY BACKUP:

The Sandman features an internal rechargeable battery backup that is not userreplaceable. If the power would go out while an alarm is set, the alarm will still ring at the time it was set for.
